### ***Interesting Facts:* Understanding the Tax Changes in the 2025 Budgets.**

Tax is calculated as a percentage of your income. The Standard Rate is 20% and the Marginal rate is 40%. The Marginal Rate is applied to amounts of income earned over a prescribed amount, known as the rate band which is influenced by your circumstances and may be different for different people. Once your tax is calculated at the appropriate percentage it is then reduced by the value of credits you are entitled to thereby determining what you must pay. As well as tax credits there are also tax reliefs. Unlike Credits reliefs reduce the income on which your tax is calculated. The most Common relief is contribution to a pension fund. E.g if you pay €100 a week into a pension fund and you earn €700 a week. The amount on which tax is calculated becomes €600. Reliefs are more beneficial to people on higher rates of tax.
